Position Summary:

Essential Duties and Responsibilities:

- Ability to drive, operate skillfully and safely clamp, single and double-blade forklifts in accordance with OSHA standards.
- Must be able to perform basic maintenance checks and record information on assigned forklift.
- Ability to pull, stage and ship case good shipments with 100% accuracy.
- Ability to accurately check in, unload and put away all inbound materials.
- Ability to accurately load and ship cased goods from a BOL.
- Ability to provide forklift support for bottling line operations as needed.
- Ability to record and locate case goods to the proper assigned warehouse lanes from the production lanes or within the warehouse lane system to maximize and utilize the optimum use of warehouse space.
- Ability to palletize case goods, perform special projects and able to repeatedly lift up to 60 lb.
- Ability to count and record accurately all case good physical inventories.
- Coordinate warehouse staging of glass, dry goods and finished goods under the guidance and direction of the Warehouse Supervisor while coordinating such activities with bottling line forklift operators.
- Ability to perform additional duties, as assigned by the Warehouse Supervisor and/or Manager.
- Complete understanding of safety procedures for assigned work area.
- Maintain a clean and safe work environment on a daily basis.
- Maintains a positive and professional attitude at all times.

- 2+ years of recent Forklift operations/experience with previous certification.
- Ideally 2 years of warehouse operational experience loading/unloading trailers, processing Bills of Ladings, receiving and shipping documentation.

- Good math and English reading and writing skills.
- Attention to detail and good organizational skill.
- Ability to work overtime when required.
- Ability to "multi-task" and handle various duties within a work schedule.

- Good interpersonal skills and ability to communicate effectively with Purple co-workers, Supervisors/ Managers, truck drivers and other personnel as needed.
